### STAMP DUTY & SDLT CHECK

You will also need to factor in the amount of stamp duty you will need to pay. The amount payable will depend upon a number of factors including what, if any, other property you own or have a major interest in and whether or not you are a first-time buyer. Different rates also apply if you reside outside of the UK or have done for 6 months or more within the last 12 months.

### SDLT CHECK

We have now partnered with SDLT Check who are tax specialists with over 25 years of experience, helping property buyers like you, ensure the correct SDLT is paid and accurate Stamp Duty Land Tax (SDLT) reliefs are claimed where available. This means that your tax return will be checked by and you will have access to a tax specialist prior to submission of the SDLT Return, which is a self-assessment tax.

### AML SEARCH FEE

The AML Search Fee covers administrative costs payable to our supplier for use of their identification and source of funds verification technology together with our administrative costs.

### LAND REGISTRY FEE

The fee quoted in the table presumes the application can be submitted to the Land Registry electronically and is eligible for a 55% reduction on the full fee payable. Some applications have to be submitted by post and will attract an increased fee. This includes new properties being registered for the first time and older properties with unregistered title deeds which have never been registered at the Land Registry.

## INFOTRACK SEARCH SERVICES PACK FEE

As a buyer you are deemed to have knowledge of information contained in public records. The search services pack includes searches of the local authority, water authority and coal board's public records as well as a comprehensive environmental report (includes HS2 and flood risk). Additional searches may occasionally be recommended. The fee also includes unlimited Land Registry documents and pre-completion searches and unlimited use of DocuSign in addition to administrative fees payable to Infotrack for use of their integration technology with Land Registry, lender panel portals and HMRC, all of which help to speed up transaction times! Where a search pack is not required or searches are supplied by a third party, a no-search admin pack fee of £75 plus vat will be payable to cover these additional administrative costs.
